
**AMENDED SCHEDULING ORDER FOR MOTIONS

The Motion to Lift Stay is partially granted. The stay will remain in effect insofar as the actual participation in trial preparation or motion practice, until such time as the Court has decided whether or not to completely lift the stay or not.

Participating parties may file a claim of interest and their legal position regarding Stream System Issue SS-97-104 on or before August 30, 2010. The parties currently in mediation pursuant to the stay may file objections on or before September 17, 2010. The Court will enlarge the time, the deadline for filing notices of intent to participate until September 15, 2010 and will consider any motions past that.

On Friday, September 24, 2010, anyone can then address and comment on any other party's statement that they have made before that, and the hearing will remain on September 28, 2010 at 1:30 p.m.
