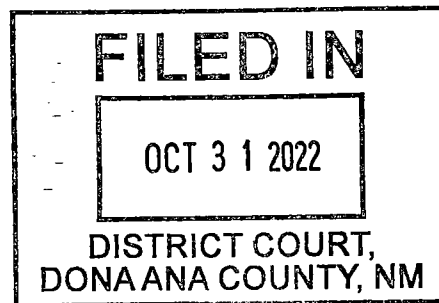


**SECOND GLOBAL ORDER ADDING ASSESSED ACREAGE FOR CERTAIN

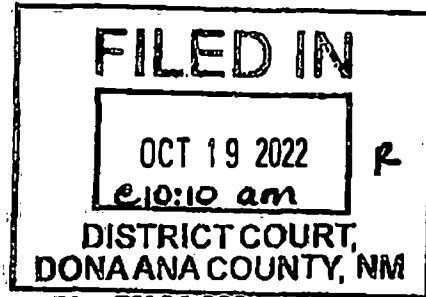
