**ORDER EXTENDING DISPOSITIVE MOTION DEADLINE AND AMENDING
APRIL 8, 2025 SCHEDULING ORDER**

This matter came before the Court on the Motion to Extend the Dispositive Motion Deadline and Amend the Scheduling Order ("Motion") filed by the Plaintiff, State of New Mexico. The Motion was not opposed by any of the responding counsel for participants in SSI 107 and the granting of an Order to modify the scheduling order as indicated below was not opposed by any of the responding counsel for participants in SSI 107.

The Court having considered State of New Mexico's Motion to Modify the Scheduling Order hereby grants the Motion.

The Scheduling Order entered on April 8, 2025 and amended on August 28, 2025, by this Court shall be modified and amended as follows:

1. The deadline, in Paragraph (5) of the Scheduling Order, for threshold motions and Rule 1-012(B)(6) motions shall be moved from October 14, 2025, to December 8, 2025
2. A deadline for responses to dispositive motions shall be set for January 16, 2026;

3. A deadline for replies to responses to dispositive motions shall be set for February 6, 2026;
4. A date shall be set by the Court for oral argument on dispositive motions;
5. All deadlines in Paragraphs (6) through (14) of the Scheduling Order shall be stayed until after the Court rules on all dispositive motions;
6. If dispositive motions do not resolve SSI 107, then within one (1) week of the Court's ruling on all dispositive motions, the parties shall reconvene and stipulate to a new scheduling order for the remainder of the proceedings.
